#### **About Us**

Welcome to Age UK Blackburn with Darwen. We are a charity (registered charity number 1143809) working with and for older people and their families and carers, in Blackburn with Darwen in Lancashire. Through the services and support we provide we aim to promote independence, improve health and wellbeing and enable older people to access the information they need to make informed

decisions about their lives. We work with older people to use their own networks, skills and abilities and to encourage active ageing, along with supporting the most frail and vulnerable to continue having a fulfilling life. The charity has been in existence since 1976, originally as Age Concern Blackburn & District. In 2011 we changed our name to Age UK Blackburn with Darwen. We are a partner of the Age UK network which is comprised of 110+ local partners and our national Age UK partner, which are each independent charities working together to deliver a shared strategy through a legal Network Agreement.

We have a programme of engagement to understand the needs of older people and inform future delivery and priorities.

## **Funding**

Our activities are funded from a variety of sources including two commissioned contracts with the local authority and a range of grant funding. Most of this funding is to pay for specific delivery so to meet our core running costs we also deliver a community fundraising programme, have a charity shop in Darwen and have income from some charged for services. Funding is an ongoing challenge and continuing to develop and diversify our income sources is a key priority.

# Partnership and Influencing Activity

In addition to the delivery of services, to achieve our mission we play an active role within the Blackburn with Darwen area sitting on a number of key strategic boards and development networks; and work across the wider Lancashire area on developments relevant to older people. We also coordinate the strategic Blackburn with Darwen Age Well Partnership of which the Chief Executive is Vice Chair. We work closely with other Age UK local partners and the national charity on joint developments and in particular work in partnership with Age UK Lancashire with which we also have a joint Community Interest Company. The Chief Executive is also Chair of the national Services for Older People Committee.

#### Governance

The charity is governed by the board of trustees who are all local people and who bring a broad range of skills and experience to the organisation. We strive to have 8 trustees including the Chairman and Vice Chairman. At present the role of Honorary Financial Adviser is vacant so the board pay for independent financial oversight to be provided.

The board usually meet 6 times a year on a planned schedule and at each meeting receive reports from the Chief Executive and Finance Manager, along with a rolling programme of update reports on each area of business. Occasionally additional board meetings may be called to discuss particular items/decisions. Each scheduled board meeting lasts for 2-3 hours, and papers are provided 5 days prior to the meetings. Board meetings are usually held face to face in Blackburn but may take place using Microsoft Teams.

The board has an Investment Sub Committee and also uses a model of convening task and finish groups with trustee membership to work on particular tasks and trustees are asked to be involved in these relevant to their skills and experience.

The attached trustee role outline provides more detail on the role and requirements.

The charity also has a trading company, Age UK Blackburn with Darwen Trading Limited, which can be used for any activities which are outside of its charitable purpose but this is currently dormant.

#### **Recruitment Process**

If you are interested in joining our organisation please complete the **application form** and return it to <u>admin@ageukbwd.org.uk</u> or 4 King Street, Blackburn, BB2 2DH.

We will then contact you to arrange a discussion with the Chairman and Vice Chairman of Trustees and Chief Executive at which point it will be mutually agreed whether to proceed with the appointment. If it is agreed to proceed, we will then send for references from the referees provided. Upon receipt of satisfactory references the Chairman will recommend the appointment at the next full board meeting or the AGM (whichever is the sooner) for approval. Following this we will provide you with an induction pack, introduce you to the organisation and complete the registration formalities with the Charity Commission and Companies House.
