#### How to leave a gift in your will

We always recommend that you speak to a qualified professional when making or amending your will. We can help you find a solicitor through our Will Writing Service, if needed. If you choose to leave a gift to Age UK Nottingham & Nottinghamshire in your will, you will need specify the following details:
