#### 2. JOB PURPOSE:

To work across the Wellbeing Checks with Meals team providing a range of services for older people on behalf of Age UK Southampton and Age UK Wiltshire.

The Wellbeing Checks with Meals team are responsible for processing customer orders, delivering heated meals to customer homes and engaging with older customers who may have age related health conditions.

The role of the customer facing driver is to plan, process and deliver heated meals to older customers living in their own homes in the community. This needs to be undertaken in an efficient and timely manner, with empathy, understanding and communication with our customers to ensure the service reflects the values of Age UK Southampton and Age UK Wiltshire. The driver will also be responsible for data and information capture, processing and application to enable effective teamwork and communication.
