

Age Cymru Dementia Advocacy Project Communication Tools Brief February 2021

1. Who are we?

Age Cymru is the national Charity for older people in Wales, we work with our 5 local Age Cymru partners to improve the lives of older people in Wales.

We have a shared vision of an Age Friendly Wales and together we work to make life better for older people in Wales through our influencing and campaigning, through free, high quality information and advice and through a range of services available in our local communities.

2. What Age Cymru project is this for?

We are seeking to develop a range of communication tools to support the work of our Dementia Advocacy project, funded by Welsh Government through the Gwent Regional Partnership Board to support older people with dementia and those who are going through the process of getting a diagnosis.

This project is about enabling people with dementia access to services and support that they need and to have a voice in decisions that are being made. It is also to support them though situations where they may be abused and need to find safeguarding solutions.

During this COVID19 pandemic people with dementia are particularly impacted with restrictions they don't understand and can't comply with, the need to access services which might be difficult to do, carer breakdown with the lack of any community or respite services. Advocacy is a vital service for these people.

For most people, making their own decisions and choices is a matter of considerable importance. Being part of decision-making processes is not only where self-identity is expressed but is also an important aspect of personal freedom. This principle is at the heart of advocacy services for people living with dementia.

Our advocacy service aims to shift the balance of power to maximise the level of influence people with dementia have over their own lives. We aim to ensure their voice is heard, the views and wishes are considered and that their rights are upheld.

The need for advocacy for people with dementia, who face complex issues around social exclusion and deteriorating cognitive function is much broader than access to statutory services and treatment. This Independent advocacy service provides support for people to:

- make changes and take control of their life
- feel more valued and included in their community
- be listened to and understood.

Due to the ongoing Covid-19 pandemic out advocates have not been able to deliver face to face advocacy which for some people with dementia can be challenging. We have been seeking innovative ways to deliver our advocacy service until it is safe to return to face to face working.

3. What are we looking for?

We are looking for the successful company to design and develop a range of communication tools and techniques to improve the way we are able to effectively communicate with people who have dementia or who are going through the process of getting a diagnosis and especially those people who are no longer able to communicate via speech alone due to cognitive impairment.

All outputs need to be bilingual or available in English and Welsh and should include but not be restricted to:

- Visual aids
- Auditory aids
- Digital applications
- Tactile resources

4. Why?

The reasons for the development of these tools and techniques are:

- To increase the ability of the project's clients to communicate their views, wishes and feelings with our advocates
- To provide our advocates with effective tools to support their work
- Demonstrate our effectiveness and support for older people
- Capture feedback and evaluation
- To capture key stakeholder feedback to inform service delivery and care provision
- To support reminiscence and story telling

5. Who are we benefitting?

We want these tools and techniques to benefit people who have dementia, especially those who's cognitive abilities have declined to the point where they need additional aids to communicate effectively their views, wishes and feelings.

6. When?

We are keen to appoint a contract by 18 March 2021.

We expect the work to be completed by 31 July 2021

7. Requirements

Age Cymru operates to clear brand guidelines that must be adhered to. These will be provided.

- The proposal will explain what action will be taken to achieve the brief.
- The proposal should contain case studies and/or customer testimonials for past work.
- The proposal must not be longer than 4 sides of A4.
- The proposal will be outcome focused rather than output focused i.e. not based on number of days work.
- The proposal must provide a breakdown of how the money will be spent.

Due to the requirement for bilingual assets we will be seeking to work with a company based in Wales.
